Industrial Development Corporation, Norris Skenandore reported about the trip to NCAI Industrial Conference at Chicago. He also informed the tribe he was applying for a mini grant from NCAI to help cover expenses of the Corporation.

8th grade up and parents. There is to be a pot luck dinner to honor the seniors in High School.

Irene Moore second the motion by Joycelyn Ninahm to pay \$15.00 to the drummer of the Winnebago Indian Dancing Group.

Joycelyn Ninham made a motion to contribute \$100.00 to PRIDE at Stevens Point for India Education. Second by Amelia Cornelius, motion carried.

Amelia Cornelius made a motion to accept the release of 21.96 acres of the Emroy Cornelius assignment, second by Irene Moore, motion carried.

It was decided to contact Mr. Peipenbrink about the fair rental value of the former Ira Adams assignment.

Joycelyn Ninham withdrew her application as Community worker for Oneida as she felt she was not in the low income bracket as required.

Amelia Cornelius made a motion to accept the application of Mrs. Evelyn Danforth as the Community worker for Oneida. Second by Joycelyn Ninham, motion carried.

Purcell Powless will attend the Governor's Conference on Industrial Development on May 21-22 in Madison.

Irene Moore, Joycelyn Ninham and Amelia Cornelius are delegated to attend the Leadership Training session in Minn. On May 19-23 which is sponsored and paid for by ICAP.

Joycelyn Ninham made a motion to approve the resolution No. 68-17 to lease property to Mrs. Irene Moore, second by Amelia Cornelius, motion carried.

Amelia Cornelius made a motion to amend the Tribe Ordinance of April 20, 1963. Second by Irene Moore, motion carried.

Joycelyn Ninham made a motion to have reproduced copies of selected Oneida Indian Treaties. Second by Irene Moore, motion carried.

Motion to pay bill, second and carried.

Joycelyn Ninham made a motion to accept the relinquishment of Oneida membership of Albert I. Bowman, Bernard V. Bowman, Myrna Fay Juneau Galbreath, Julene Marie Galbreath, Tana Jo Galbreath, Spencer Gorman, Ramone Jean Powless, Cheryl Lee Many Wounds and Pamelia Rae Many Wounds. Second by Irene Moore, motion carried.

Amelia Cornelius made a motion to approve the Oneida Membership Roll with approved corrected changes in accordance with act of 9/27/67. Second by Irene Moore, motion carried.

Amelia Cornelius made a motion to cancel the land applications of Leland Cornelius, Caroline Lammert, Elmer Summers and Elsie Johnson. Second by Irene Moore, motion carried.

Amelia Cornelius made a motion to revoke the grant of assignment of Elizabeth Dennison and Phillip Skenandore because they are not living on the assignment. Second by Joycelyn Ninham. Motion carried.

Motion to adjourn, second and carried.
