Ira Cornelius made a motion to send out 'notice of hearings' to Willard Johnson, Leona Smith, Robert Schuyler and Alex Cornelius to attend meeting on De. 29, 1969 and also for the Council to prepare for semi-annual meeting. Second by Joycelyn Ninham, motion carried.

Amelia Cornelius made a motion that the Land Committee work with the Citizens Advisory Committee and Brown County Planning Commission to set up a plan for the best use of all tribal land in Brown County. Second by Norbert Hill. Motion carried.

It was reported that a Mr. Newfeldt had stated the land of Lester Skenandore was worth at least \$1,000.00 per acre.

Letters of Commitment needed for the Community Building possible sources: Headstart, CAP, NYC Industry, Library, VISTA, Housing Authority, Pre-apprenticeship program and Employment office. Must be in before Dec. 31.

Priorities presented to Mr. LaMere for O.E.O. program. 1. Head start, 2. Senior Citizens, 3. VISTA 4. N.Y.C. fulltime supervisor, 5. Health programs

Loretta Ellis gave a report on the Educational Committee. The booklet Indian Education A National Tragedy A National Challenge can be gotten from the senate publications bldg. Washington, DC.

Joycelyn Ninham made a motion to appoint a committee to investigate the problems of Indian students in school and recommendations of how to solve the problems. Second by Norbert Hill, motion carried.

Mr. Arbuckle, Reservation Youth Project Coordinator, reported that he would like the name of a youth between the ages of 16-25 to attend the Presidents Council on Youth.

Two names suggested: Ron McLester and Edna Cornelius.

Amelia Cornelius made a motion to pay bills. Second by Irene Moore. Motion carried.

Norbert Hill made a motion to contact the Fox River Human Rights Commission in regards to Rudy Webster being behind over \$50.00 in his lite bill. If the bill is not paid in 10 days the tribe is to turn off the electricity and have the bill put in Rudy Webster's name. Second by Amelia Cornelius. Motion carried.

Amelia Cornelius made a motion to have Judy Barton to represent the tribal council on the Headstart policy advisory committee to replace Joycelyn Ninham. Second by Joycelyn Ninham, motion carried.

Irene Moore paid \$90.00 for land rent, \$10.00 was deducted from rent for bill presented by Simon Moore for cutting law. Total rent is \$100.00.

Ira Cornelius made a motion that the tribal council write a letter of support to the VISTA tutoring programs and other projects. Second by Norbert Hill, motion carried. 1 present only vote.

Motion to adjourn, second and carried.
