The meeting called to order at 7:30 p.m.

Reports were dispensed with as not enough persons present. Bill Gollnick and Jennie Webster students of UWGB Indian Committee Organization of Indian Students request for a council member to attend their meetings.

Read letter about a person interested in compiling history of the Oneidas and would like to spend some time in the area. Would be working with UWGB. Referred to Education committee for action.

Reports: Anna John – Health Committee, Wanda Webster's report, Sharon Webster's report.

Joy Ninham moved to accept Mrs. Johns report, seconded by Ira Cornelius. Motion carried.

Head start report by Anna John. Joycelyn Ninham moved to accept report. Seconded by Ira Cornelius. Motion carried.

Ira Cornelius moved to have Anderson Cornelius place locks on the tables and benches in the gym. Seconded by Gordon McLester. Motion carried.

Sonny King requested the use of the gym for basketball practice on Mon. 7 p.m., Wed. 8 p.m., and Sat. 1:156 p.m. Request granted.

Amelia Cornelius moved that an inquiry be made about rent from BIA office space. Headstart space and for enrollment monies from GLITC. Seconded by Gordon McLester. Motion carried.

Judy Barton moved that the Secretary write up a "contract" for use of the building and that a responsible adult supervise all activities and to especially keep the bathrooms clean. Second by Amelia Cornelius. Motion carried.

Anderson Cornelius reported that the Housing is 95% complete. The main work to be completed is the sewer and water, fix the roads and finally to landscape.

Ira Cornelius moved to adopt new priority for IPH. 1. New water system at tribal building and 2. Individual water and sanitation facilities for Indian homes within reservation boundaries. Seconded by Gordon McLester. Motion carried.

Amelia Cornelius moved that Anderson Cornelius order course rock for window pits and tribal buildings. Seond and carried.

Joycelyn Ninham moved to delegate Judy Barton to attend meeting at Alburquerque for National Indian Educatoin Conference. Second by Alma Webster. Motion carried.

Joy Ninham moved to pay bills, second by Ira Cornelius. Motion carried.

Judy Barton moved to request that the lands formerly held in redeemed status for Lucy Skenandore Denny be plotted in 1 acre sites and with roads for accessibility after a feasibility study is made by a BIA representative. Seconded by Ira Cornelius. Motion carried.

Ira Cornelius moved to table the request from Richard Summers for a lease application on his mother's redeemed land until the Dec. meeting. Seconded by Judy Barton. Motion carried.

Joy Ninham moved that the Education Committee name their own delegate to the Wisconsin State Indian Education Committee. Second by Judy Barton. Motion carried.
