

Norbert Hill made a motion to adopt a resolution authorizing the BIA to formulate a contract to obtain \$3,725 for aerial maps that will be used in a land use study on the Oneida Reservation.

Chairman Purcell Powless appointed Howard Cannon as Secretary of the Land committee. Land committee members are Julie Barton, Norbert Hill, Wendell McLester, Robert Schuyler, and Howard Cannon.

Norbert Hill made a motion to accept Milton J. Skenandore's application for a residential lease. Loretta Ellis seconded. Carried.

Loretta Ellis made a motion to send the information requested by Wisconsin Legal Services concerning the Joseph Webster lease. Norbert Hill seconded. Carried.

Loretta Ellis made a motion to adopt the resolution to support having a foot bridge over Duck Creek adjacent to the auto bridge on Highway 54, town of Hobart, in Oneida, Wis. Irene Moore seconded. Motion carried.

Irene Moore made a motion to adopt the resolution to submit the Oneida Tribal Administration Budget to the Donner Foundation. Loretta Ellis seconded. Motion carried.

A request was made for the secretary to make copies of the minutes to be distributed to the Business Committee.

Gordon McLester made a motion to reimburse \$10 to the two Halloween Party Centers that didn't have prize money. Norbert Hill seconded. Carried.

Irene Moore made a motion to pay bills. Norbert Hill seconded. Motion carried.


Irene Moore made a motion toádjourn. Loretta Ellis seconded. Meeting adjourned.

Modification No. 2

REQUEST FOR MODIFICATION OF LOAN AGREEMENT

Contract 14-20-0350-329, between the Oneida Tribe of Indians of Wisconsin and the United States.

The Oneida Tribe of Indians of Wisconsin, as evidenced by a resolution of its Business Committee adopted at a meeting held October 19, 1972 a certified copy of which is attached hereto, requests that contract 14-23-2353-329 be modified as follows:

FACES

. The Tribe is indebted to the United States for \$60,000 which is videnced as follows:

A. For Tribal Industrial Park Promissory note of May 22, 1967, for \$60,000 bearing 5½ percent per annum on which the unpaid balance is \$60,000. No interest had been paid.

1. The indebtedness is secured by Resolution No. 7-67B, dated July 3, 1987, which pledges payment from the Judgment funds to be received by the Oneida Tribe of Indians.

PROVISIONS:

1. The commitment under this contract is increased by \$18,750 to a total of \$73,750 to provide additional financing for the Oneida Tribe of Indians of Wisconsin. The additional advance shall be evidenced by a promissory note payable in twenty (20) equal installments of \$930 and a final payment of \$150 beginning on or before July 15, 1975, with the final installment due on or before July 15, 1995, with interest payable annually at 5½ percent per annum. The amount will be advanced subject to the availability of funds upon request of the authorized tribal officers. In the event the entire amount is not advanced within one year from date of approval, for any reason whatsoever, the unadvanced portion will be automatically cancelled, unless otherwise authorized by the Commissioner.

2. The promissory note of May 22, 1967, shall remain in effect and the accrued interest on the note of May 22, 1967 shall be paid to June 33, 1972.
