

BUSINESS CONDUCTED: Chairman called meeting to order. Prayer by Irene Moore. Roll call of officers. Minutes from February 5, 11, 26, and March 1 were read. Correction of Feb. 5 minutes. The sentence "Norbert Hill moved to amend the motion to hold lease applications in abeyance for land description to include the agricultural lease of Austin Summers, Jr." to be stricken from the minutes. The rest of the minutes approved as read.

Irene Moore made a motion that the Business Committee meet with the 701 Planners on March 14, 1973, at 7:30 p.m. Alma Webster seconded. Motion carried.

Eva Danforth made a motion the Tribal Council hire Loretta Ellis as a consultant, when her services are needed. Norbert Hill seconded. The motion carried, 7 for, 1 abstain.

Irene Moore made a motion to pay bills. Wendell McLester seconded. Motion carried.

Norbert Hill read resolutions concerning National American Revolution Bi-Centennial Commission. Loretta Ellis moved to table these resolutions until the next meeting. Eva Danforth seconded. Motion carried.

Frank Cornelius requested permission from the Tribe to lease the tribally-owned building at the CCC site for a grocery store. Loretta Ellis made a motion the Business Committee approve Mr. Cornelius's venture and that he proceed with the Tribal Manager, Mr. Cannon and Mr. Irene Moore seconded. Motion carried. Bolin.

Loretta Ellis made a motion the Business Committee authorize Norbert Hill to proceed with a workable program, and negotiate for Buy-Indian contracts for all programs. Wendell McLester seconded. Motion carried, 7 for, 1 opposed.

Norbert Hill made a motion the Town Chairman meet with the Land Committee for road improvement, the Land Committee to submit their recommendation to the Business Committee. Loretta Ellis seconded. Motion carried. Norbert Hill motion to adjourn. Irene Moore seconded. Carried.
