Gordon McLester moved the Council have a special meeting July 30, at 7:30 p.m. to evaluate the Aid to Tribal Government Development Program. Wendell McLester seconded. Carried.

Discussion of policies and procedures. The Tribal Manager will make up a rough draft and present it at the meeting on the 30th of July. Also he will develop job application form.

The Secretary will write a "thank you" letter to Mr. Jack Campisi for the carving he presented to the Tribe. Gordon McLester motion to adjourn, seconded by Wendell McLester. Carried.
