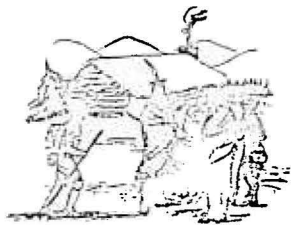
Head Start report by Dellora Cornelius. Wendell McLester moved for approval. Alma Webster seconded. Carried.

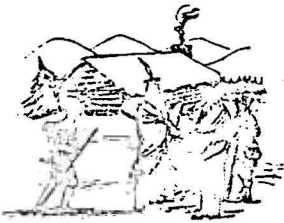

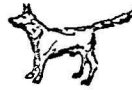
