### BUSINESS CONDUCTED:

Purcell Powless called the meeting to order at 8:00 p.m. Prayer by Wendell McLester. Mr. Diederick spoke on the Housing Allowance program and answered questions. He is located on the 5th floor of City Hall in Green Bay.

Roll call of officers. Quorum present. Minutes of July 1 and 5 were read. (Carlton Smith's motion was deleted) and approved as corrected. Minutes of July 6 and 11 were read and approved as read. (Discussion of July 11, Business Committee minutes. Legality of voting in abstentia. Decision to leave minutes as is. Matter will be taken up, if situation arises again.)

The Chairman discussed the meeting in Minneapolis for Title 11 money, and the decision to fund the Building Manager's position.

Neil Olson presented a request from the Right-to-read program for \$600 to pay Mr. Richard Chrisjohn to come to Oneida. He will work on a consultant basis with the Oneida Language Program, Arts and Crafts, video tapes, etc. The money will be repaid by the Right-to-read Program. Wendell McLester moved to approve the request. Gordon McLester seconded. Motion carried.

The Emigrant Claim was invested June 11 for 1 month and received \$14,164.80 interest.

The Chairman reported that Reggie Miller has been unsuccessful so far, in his efforts to set up a meeting with SBA concerning the Industrial Park.

Wendell McLester moved to approve the residential lease application of Gordon and Judy Skenandore, contingent on approval by the BIA. Eva Danforth seconded. Motion carried.

Norbert Hill moved to adopt a resolution supporting Sandy Mc Nab to the Indian Desk in the Department of Labor. Wendell McLester seconded. Motion carried.

Congressman Froelich will be in Green Bay next week.

Bill Gollnick reported on the Oneida Language project.

Gordon McLester moved to adjourn. Wendell McLester seconded. Mtg. adjourned.
