Arthur Ybeck will be here December 11 at 9:30 a.m. to meet with the Tribe to discuss possible sources of garbage removal. Indian Health needs a resolution from the Tribe requesting a garbage truck. Eva Danforth made a motion the Tribe persue this. Irene Moore seconded. Motion carried.

There was discussion of the letters from the attorneys Buzz Barlow and James Doyle. Margaret Doxtater made a motion to table the letters. Norbert Hill seconded. Motion carried, 6 for, 1 opposed. Norbert Hill will follow up on this for the next meeting.

Mr. Gene Birrell and Mr. Al Mueller were introduced. Mr. Birell is with Native American Technical Assistance from Albuquerque. Mr. Mueller represents the Jason/Murphy Co. from Chicago and is interested in locating in the Industrial Park. Mr. Mueller invited the Chairman to tour the plant in Chicago to see it in operation before any further action is taken.

The Day Care request was discussed, also the availability of funds. Irene Moore moved to table the request until the next meeting. Norbert Hill seconded. Motion carried.
