Loretta Metoxen moved to discuss the disposition of the \$10,230 from BIA for Tribal Programs after discussion of the 638 funds. Second by Margaret Doxter, motion carried 3 for, 2 opposed.

Discussion on use of the Tribal Program funds in amount of \$10,230 and 638 self determination funds in amount of \$97,700. Economic impact study, Public relations, Personnel management, etc.

Robert Thomas moved to direct Pat Smith to contact program directors and to find out needs in regard to 638 funds. Second by Amelia Cornelius, motion carried.

Loretta Metoxen moved to approve the request to extend the probationary period from 3 months to 6 months for the RNIP program.
