REGULAR MEETING October 15, 1979 8 p.m.

Meeting was called to order at 8 p.m. Prayer was said by Mark Powless. Swearing of new officers was by Frank Cornelius: Treasurer, Wendell McLester, Secretary, Wanda Webster.

MINUTES: The Special Meeting minutes of 9/21/79 were corrected by Loretta Metoxen as follows: "Resolution presented for the Health Board to reactivate and serve of the Bemidji 3-State Area Health Board." Minutes were approved as corrected. The minutes of 9/28/79 special meeting, 10/1/79 regular meeting were approved as written.

September 17 meeting, Loretta Metoxen stated she was ill, not absent. <u>OLD BUSINESS:</u> Uneida Housing Authority: Motion made by Margaret to approve September

report of Housing Authority. Norbert seconded. Motion carried unanimously.

Margaret moved to approve Nancy Hardman as Income Maintenance WOrker. Norbert seconded. Motion carried unanimously.

Discussion on salary increases. Personnel office has had many inquiries regarding salary increases. It was recommended by Ted WHite that increases not exceed 8 per cent. Norbert moved to approve recommendation, Margaret seconded. Vote was 6 for 1 oppose (Myron). Motion approved.

Margaret moved to approve \$50.00 a month salary increases for Arletta Kurowski and Joylyn Cornelius. Mark seconded. Vote was 6 for and 1 oppose (Myron). Motion carried.

Loretta moved to approve Marie Faye Smith as Library Assistant, Margaret seconded. Motion carried unanimously.

Loretta moved to recommend Joseph Webster as Head Start Van Driver, Margaret seconded. Motion carried unanimously.

Mark moved to recommend Joseph Villagomez as Nutrition and Energy Coordinator, Margaret seconded. Vote was 5 for and 2 oppose. Motion carried.

Mark moved to approve 5 more days for technical assistance training, Margaret seconded. Motion carried unanimously.

<u>Memo from Fran Skenandore</u>: Tribal Lawer will be attending a public hearing on the proposed rules regarding cigarette sales to and by Indians on Indian Reservations, on Oct. 22, 1979. Mark made motion that if the State does not comply, the Oneida Tribe should take legal action. Wendell seconded. Motion was carried unanimously.

Education Report: Loretta made a motion to adopt resolution for Johnson-O'Malley funding, and go for Formula 7. Mark seconded motion. Motion carried unanimously. Ron Skenandore stated he will be hospitalized 2-4 weeks starting Oct.22.

Land Committee: Margaret moved to approve the following lease applications: David & Doris Smith, Gordon & Judy Skenandore. Wendell seconded the motion. Motion carried unanimously.

Mark moved to approve the lease application for Wayne & Elaine Skenandore. Norbert seconded. Motion carried unanimously.

Mark moved to approve agriculture appl. for Anthony Benson. Norbert seconded. Motion carried unanimously.

Mark moved to approve Homesite lease for Theda M. Kirby and son Daniel V. Kirby. Loretta seconded. Motion carried.

Mark moved to approve Residential lease for Edward D. and Gladys A. Stevens. Loretta seconded. Motion carried unanimously.

Norbert moved to approve Residential lease for Mark A. and Debra Powless. Wendell seconded. Vote was 6 for and 1 abstention. (Mark)

Health Center Report: Margaret made motion to approve August report. Wanda seconded. Vote was 6 for and 1 abstention. (Mark) Motion carried.

Margaret moved to approve September report. Norbert seconded. Vote 6 for and 1 abstention. (Mark) Motion carried.
