Norbert stated he had called Dr. Demonity in Maryland regarding public service funds.

Audrey read a letter from Mr. Buckanaga stating that efforts should be made locally to maintain the lagoon. She will be meeting with IHS tomorrow (3/20/80) in Rhinelander and will find out more.

Mark stated he checked out the Utilities Commission, when they were formed and some of the things they were to do. They did not carry out their responsibilities. There is no Utilities Commission at the present time. There were 2 members from each site when it was set up.

Mike Schaepe had a list of items that need to be done to adequately address the problems of the lagoon for a short term basis.

Eugene Cornelius stated most of these things are being done now, except the lab.

Mike suggested that the Sanitarian's office prepare a work schedule on what they plan to do and what they are presently doing on these 11 points. He also read a letter from the DNR regarding the funding for a new treatment facility. They are presently reviewing an application for funding.

Discussion on a new treatment facility, how it would effect the area. The present lagoon will never adequately serve the community properly.

Margaret will be going with Audrey to Rhinelander tomorrow. It was decided that the Health Center and Mike will work together to see what can be done to address the lagoon situation.

Meeting adjourned at 3:25 p.m.
