PRESENT: Chrmn. Purcell Powless, Secretary Wanda Webster, Loretta MEtoxen, Edwin King JR., Mark Powless, Wendell McLester.

ALSO PRESENT: Herb Hoelter, Bruce Schaepe, Kathy Hughes, Ted White, Rose Melchert Richard Shikoski.

Purpose of the meeting was to meet with Mr. Hoelter and have him explain the proposed Green Bay site for a Post Office in the Industrial Park. The Postal Service's intention is to purchase the Green Bay site for development of a new postal facility. Public invitiations to bid will be for a leased or a postal owned facility, the Postal Service will then award to the lower bidder, based on total construction cost or annual rental, as determined by a formula included in the bid package. If a lease bid is the most conomical, the postal service will sell the land to the winning bidder ar cost. Lengthy discussion followed in regards to turning the land into trust, the bidding process, and tax exempt bonds. Mr. Hoelter stated he thinks there will be no problem with Oneida getting the bid. The bidding process will be from June to September, 1981.

Mr. Hoelter stated his contract will expire July 17, 1980 and it should be amended to include the Indisutial City Site, rather that the Industrial Park.

Mr. Hoelter stated he knows of a person who is interested in putting a motel/hotel on the Oneida's airport lands. He requested a contract to work on a plan on putting a first class motel/hotel on the airport lands. It was suggested that he leave the contract here and we will have the Law Office review it.

INDIRECT COST PROPOSAL - 1981:

Wendell presented memo requesting Ray Roe to do certification of the accounting system. for the 1981 indirect cost proposal. Discussion on the people that are working in the accounting office should be qualified to do the proposal. Wendell stated it is the responsibility of the staff to do the work, Mr. Roe would provide technical assistance and certification of the accounting system.

Motion was made by Loretta to offer Mr. Roe \$1000 plus expenses to do this. Edwin seconded Discussion: Wendell stated those making the motion should provide for technical assistance personnel to come in and help. Vote was 2 for with 3 opposing. Motion dies.

EQUIPMENT ACQUISITION:

Rose Melchert request that the Tribal Treasurer be given the authority to approve all \$100 purchases.

Motion was made by Mark to delegate the authority to the Purchasing Agent to approve all purchases from \$100 to \$299. Wendell seconded. Motion carried unanimously.

Motion was made by Wendell to adjourn at 3:57 p.m. Edwin seconded. No one opposed, motion carried.
