## SPECIAL MEETING

August 19, 1980  
10:00 A.M.

PRESENT: Chrmn. Purcell Powless, V-Chrmn. Norbert Hill, Secretary Wanda Webster, Treasurer, Wendell McLester, Mark Powless.

ALSO PRESENT: Audrey Doxtator, Priscilla Manders, Mary Greendeer, Michael Schaepe.

Purpose of the meeting was to discuss wells and septic system and which projects would be the priority in using up the money that remain in the contract. The contract 77-207 has \$5000 remaining in it.

A lengthy discussion on which project would take priority. It was the recommendation from Audrey, Priscilla, Mary and Mike that the following four projects be undertaken, they are listed projects of high priority and ranked in order of importance.

- 1.) Contaminated well at Elena Greendeer's.
- 2.) Nursing Home spetic system.
- 3.) Tribal building drainage field
- 4.) The Oneida Village Lagoon.

Motion was made by Mark that the number one priority should be the Nursing Home as there it services many people. Wanda seconded. Vote was 3 for with 1 abstention, (Wendell). Motion carried.

It was suggested that the Nursing Home may be able to pay for some of this cost.

### CONTRACT 79-717:

There are three wells that need to be constructed under this contract. There are four projects listed in priority, they are:

- 1.) Vera Wilson - Rochelle Primeau
- 2.) Clayton Cornelius - Christina Stevens - Russell Cornelius
- 3.) Joan McLester
- 4.) Gail Metoxen

Motion was made by Mark that the projects be Vera Wilson, Clayton Cornelius and Gail Metoxen and that Joan McLester be priority on the new project. Wanda seconded. Discussion: It was decided to include Joan on the list in case any of the three refuse. Motion carried unanimously.

### CONTRACT 77-207:

Motion was made by Wendell that the priority for the projects be: 1.) Nursing Home, 2.) Contaminated well at Elena Greendeer's, 3.) Tribal Building, 4.) Oneida Village Lagoon. Mark seconded. Vote was 3 for with 1 abstention. Motion carried.

Discussion on what program should handle the 86-121 project. Mary and Audrey both agreed it is working fine the way it is being handled now.

Meeting ended at 11:15 a.m.
