December 10, 1980 9:10 A.M. CUF "

PRESENT: Chairman, Purcell Powless; V-Chairman, Norbert Hill; Secretary, Wanda Webster; Treasurer, Wendell McLester; Edwin King Jr., Mark Powless, Loretta Metoxen.

ALSO PRESENT: Francis Skenandore, Jerry Hill, Mr. Lindstrom, Ms. Harrington, Carl Rasmussen.

Purpose of the meeting was to meet with Mr. Lindstrom of the Lindstrom Corporation, and hear a presentation of venture capital. Mr. Lindstrom stated the Tribe has investment-type property in the Industrial Park, they would build a shell type building and the tennant would do the rest of the construction. He also stated they are the largest commercial broker firm in the area and they have done many government projects before. Mr. Lindstrom then went over a sample transaction he had provided the Business Committee, Mr. Lindstrom stated everything is done by written agreements, there are no contracts. (Lindstrom Corporation leaves).

Richard Leonard, of the Law Enforcement Services, BIA, Ashland was present to provide information of the services the BIA has to offer. He stated they can provide training and assist in obtaining for a Judge, Officers and Wardens. Funds would come from Law and Order funds out of Washington. To be eligible for LEAA funds, the Tribe would have to write a letter of intent and have it published in the Federal Register. Training could be provided for Judges, Officers and Wardens with an intent published. The Indian Police Academy usually have two or three classes per year, each consisting of 11 weeks.

Mr. Leonard stated the BIA can do independent investigations, but he usually works with the F.B.I. If we would like him to do an investigation, he would need a letter from the Tribal Chairman or Vice-Chairman stating so. Mr. Leonard also stated his travel has been cut and this is probably the only time he will be in Oneida for a while.

(Mr. Leonard left).

Motion was made by Loretta that the Law Office investigate the issuing of car licenses to Tribal Members. Norbert seconded. Motion carried unanimously.

Mark asked the Law Office to bring the Business Committee up to date as to what they are doing, the Attorneys stated they are doing a report, and will have it ready before the end of the year.
