Purpose of the meeting was to review the Shoreline Protection Ordinance as presented by Mike Schaepe.

A Lease was presented for Wayne and Cleo Cornelius to assign their lease hold interest to the State of Wisconsin, Department of Veterans Affairs for \$8,000 to develop their lease hold premises.

The Land Committee adopted the resolution and recommended that the Business take action on it also.

Motion was made by Wendell to approve this request specifically because it was in process before action to stop all land transactions was taken, the lease is to be reviewed by the Law Office. Norbert seconded. Motion carried unanimously.

Mike read the letter which was sent to the agencies requesting the Shoreland Protection Ordinance be returned/disregarded.

Discussion on the procedure in which Mike followed in sending out the Ordinance. Mike stated after the Ordinance is adopted by the Business Committee there needs to be a public hearing for people to make comments on it. Discussion on who will conduct the hearing and when it should be.

Motion was made by Wendell to adopt the final draft of the Shoreland Protection Ordinance. Norbert seconded. Motion carried unanimously.

Discussion on a hearing date. It was decided to have it on December 22, 1980. Motion was made by Wendell to that the public hearing be conducted by the Land Committee. Edwin seconded. Motion carried unanimously.

Discussion on when the January General Tribal Council meeting will be held.

Motion was made by Norbert to hold a General Tribal Council meeting on January 10, 1981,

at 10:00 A.M. at the Sacred Heart Center. Wendell seconded. No one opposed, motion carried.

Discussion on Mike submitting press releases to the Kalih wisaks and Press Gazette, it was decided this should go also through the Land Committee.

Motion was made by Wendell to approve the report. Edwin seconded. Motion carried unanimous

Motion was made by Wendell to adjourn at 7:45 P.M. Norbert seconded. Motion carried unanimously.
