Purpose of the meeting was to meet with the Lawyers and review the temparory election ordinance, the Lawyers were not prepared at this time, but will meet with the Business Committee on 11/18/81 at 1:30 P.M. at the Tribal Building. At this time the Personnel Manager had recommendations for employment.

Interviews were held on 10/29/81 for Headstart Teacher and Headstart Teacher Assistant. Mary E. Sheedy was recommended for the Headstart Teacher position. The following applicants were all very close in qualifications for the position of Headstart Teacher Assistant: Roarah Teller, Debra Habech and Gloria Kurowski.

Motion was made by Mark to approve Mary Sheedy for the position of Headstart Teacher and Gloria Kurowski for the position of Headstart Teacher Assistant. Howard seconded. Vote was 6 for with 1 abstention (Wanda). Motion carried.

Discussion on the posting of another Headstart Teacher Assistant, Joe is to post the vacant position.

Motion was made by Tony that the Business Committee receive all job postings. Joy seconded. Motion carried unanimously.

Discussion on students at Haskell not receiving any funds, many of the students are leaving school because of this. Joy will ask the Lawyers to call Haskell to check on this.

Discussion on the re-organization chart, the Chairman will talk with the General Manager to set up a time.

Discussion on other business that is brought before the Business Committee at their regular monthly meetings, also discussed was putting in writing anything that is brought before the Committee. It was discussed that one of the Lawyers should be in attendance at the meetings.

Motion was made by Mark that we have one of the Tribal Attorneys present at the regular Business Committee meetings, if they are available. Tony seconded. Discussion: the Personnel Director should also be present. Motion carried unanimously.

Motion was made by Howard to recess at 11:45 until 11/18/81 at 1:30 P.M. Motion carried unanimously.

(Howard stated he is looking into the 32 acres called Dunlap's Reef in Door County, which was referred to him on 11/16/81 by Joy.)
