

Oneida Tribe of Wis. Special Meeting - Oct. 7, 1981 Oneida Health Center, 9:00 a.m.

Discussion on the opinion from Tribal Attorney Francis Skenandore in regard to the 2-14-76 resolution concerning conflict of interest by being a Tribal employee and a member of the Business Committee. Based on the opinion, Amelia Cornelius offered to submit her resignation as a member of the Business Committee. Further discussion on the uncertainty of salaried positions as a member of the Oneida Business Committee. Francis stated he felt it was important to have the legislative body being available on a full time basis.

Norbert Hill moved to hold Amelia Cornelius resignation under advisement, second by Joy Ninham, 2 for, 4 opposed, 1 abstain (Amelia).

Discussion on guarenteeing salaried position of the Oneida Business Committee Jerry Hill stated that the Oneida Business Committee is involved now in legislative responsibilities and not programs.

Joy Ninham moved to have a special General Tribal Council meeting on Oct. 24, 1981 at 10:00 a.m. to fill the vacant position on the Oneida Business Committee. The meeting to be held at the Sacred Heart Center, second by Howard Cannon, motion carried. 1 abstain (Mark).

Discussion on budget for the Oneida Business Committee, Mark suggested that the Treasurer take the necessary steps to insure the funds for the Oneida Business Committee. Discussion on problems when the Oneida Business Committee are not available on a full time basis. Further discussion on need to provide a budget for the Oneida Business Committee to guarentee salaries of the Oneida Business Committee.

Discussion of the recent New York claim which was won in favor of the Oneidas. Oneida County has 30 days to appeal. The Oneidas are asking \$400,000 and the county is offering \$0-2,000 for the land value. A memo from Francis will follow on this issue.

G.L.I.T.C. meeting will be in Oneida at the Health Center on Oct. 22, 1981. The Oneida attorneys will make a presentation about the Tobacco issue in Wisconsin as it relates to the Prosser Bill. They want to stress the need for Tribal control of the Tobacco enterprise.

### Land Business

Wendell McLester moved to accept the recommendation that the site off Johnson Road (Shirley La Fleur) be removed from the Wisc. 10-7 Program and revert to its' original status, second by Mark Powless, motion carried.

#### Personnel Office

Mark Powless moved to approve the salary for the position of Vice Chairman be set at \$22,275.00, second by Joy Ninham, motion carried.

- 3) Personnel Executive Secretary increased responsibilities to also be the secretary to the General Manager. The salary increase will come from the General Manager secretary position which will not be filled. It was posted at \$15,000. The Chairman referred the request to the Budget & Finance Committee.

Discussion on program evaluation, employee evaluations, overall cost of living increase for all employees with merit increases dependent upon evaluation.

John reported that Bob Bennett will be meeting with the Oneida Business Committee on the tribal constitution the last week of Oct. or the lst. week of Nov.
