TRIBAL BUDGET

Lloyd moved to approve the budget for Business Manager. Frank seconded. Mark abstained. Motion Carried.

BUSINESS COMMITTEE SALARY BUDGET

There was discussion on the amount to be paid to the Business Committee. Different ideas put on the table. One idea was to let the General Tribal Council decide on the salary of the Business Committee. A sub-Committee will work on some recommendations Lloyd, Mark, Wendell will work as a Sub-Committee.

Legislative advocacy is added in a line item to the Business Committee budget. Mark moved to add the line item. Wendell Seconded. Gary recommended the Tribe donate \$300.00 for the purchase of a Scoreboard. The cost is about \$1,500.00 for the Scoreboard. Gordon moved to approve \$300.00 be donated for the Scoreboard to the Menominee Nation. Lloyd Seconded. Mark and Wendell Opposed. Motion Carried.

TRIBAL PICNIC BUDGET

Mark moved to honor the petition and have the meeting on September 27, 1982. Wendell Seconded. Motion Carried.
