




Oneidas bringing several hundred bags of corn to Washington's starving army at Valley Forge, after the colonists had consistently refused to aid them.

Frank moved to approve the Health Board Minutes of August 9, 1982. Wendell Seconded. Motion Carried.


The Treasurers Report was tabled from July because you could not read the print-out. Norbert moved to take from the table. Lloyd seconded. Mark abstained. Motion Carried.
