# POST OFFICE BUILDING - Bruce King

In a memo of September 27, 1982 regarding the Post Office Building, Bruce stated, On Thursday, September 23, 1982, I was notified by Carl Rasmussen, the developer that the Oneida Tribe contracted with to secure a lease from the Post Office was hedging on placing a bid on the project. It would appear Mr. Hoelter will not be able to get financing for the project. I feel it very important for the Oneida Tribe to place a bid on this project.

Built into the contract between the Oneida Tribe and Mr. Hoelter is a clause stating there will be no other <u>outside</u> developer for this project. If we are to place a bid, we cannot have an <u>outside</u> firm to develop it.

He has leads on getting financing, bonding, and the construction firm. The biggest question I would have is whether or not we could get this all together by October 7, 1982. Also he will be available to discuss this.

Bruce said that he would need help from the Legal Office this coming week on his Post Office Project. Mark made a motion to have the economic developer proceed with the Post Office Project. Lloyd seconded. Frank abstained. Motion Carried.

#### CETA REQUEST

This request had been tabled from the meeting of last week. Wendell moved to approve the appropriation request which is: Because of CETA's difficulty in getting their budgets approved, Oneida's program will have to use carry-over until their FY '83 proposal is approved. This creates a problem with Administrative costs only, and requires drawing down on the '83 budget for administrative. The approximate amount needed is \$10,000.00 for 90 days. This was tabled because the amount was not stated at that time. Norbert seconded. Tony and Mark abstained. Motion Carried.
