WAGE FREEZE

Kathy Hughes felt more time would be needed to do a more thorough study of the Kinds and Levels Chart. Therefore, she recommended a freeze on wages for a minimum of 30 days. Tony Benson moved to freeze the wages for a minimum of 30 days, seconded by Lloyd Powless. Motion carried.
