EMPLOYMENT RECOMMENDATIONS

BINGO BUILDING

The Architect for the Bingo Building has received the bids from Construction Companies who were interested in building the building. The lowest combination of bids received were \$100,000 over the estimates supplied from the architect. The building was budgeted up to \$450,000 and the estimates have come in at \$540,000. The Architect will work with the Bingo Committee and see if there are any cuts that might be made. The amount that has been ear-marked for the building will cover the increase. The Business Committee will have the law office look at the General Contractor's lowest bidder which is Oneida Tribal Development Corporation because of the law suit OTDC has against the Tribe. Norbert moved to accept the lowest bidders on the sub-contracting. Wendell seconded. Motion carried.

There is a question on the well drilling at the Bingo Building site because of Fort Howard's holding ponds. Bruce will send a letter to Fort Howard addressing this matter.

O.R.C.O.A. ELECTION


The results of the election held at the Multi-Purpose Center on September 30, 1982 is as follows:
