



NCAI REPORT IN WASHINGTON, D.C - Lloyd Powless, Norbert Hill

The Business Committee reviewed the report given by Norbert and Lloyd. Mark made a motion to have Norbert send for the Handbook on Indian Claims from Kirke Kickingbird from the Institute for the Development of Indian Laws. Lois seconded. Motion carried.

ONEIDA HEALTH BOARD POLICIES, PROCEDURES, PLAN OF ACTION

The Business Committee reviewed a proposed ordinance outlining the establishment of the Oneida Health Board which would supercede all prior resolutions regarding their roles, responsibilities and duties.

Loretta made a motion that the Law Office redraft a proposed ordinance outlining a plan of action and submit to the Business Committee relative to Advisory roles of Boards and Committees. Lois seconded. Mark abstained. Motion carried.

MEMORANDUM OF AGREEMENT/DRAFT

The Business reviewed the agreement and discussed some changes. Lois made a motion to have Jerry redraft the agreement and bring this back to the Business Committee. Norbert seconded. Motion carried.
