Francis informed the Business Committee on the Cigarette issue--discussion followed.

BINGO UPDATE - Francis Skenandore

AUCTION OF LYLE VAN ASTEN PROPERTY

Mark made a motion for the Tribe <u>not</u> to consider the purchase of the Lyle Van Asten property at this time, the reason being that a farm plan has not yet been developed as of yet. Lloyd seconded. Loretta, Gordon, Norbert opposed. Motion carried.

PRIVATE SECTOR PROPOSAL - Bob Christjohn

Lloyd made a motion to approve the Private Sector proposal contingent on review by Lloyd and Bob Christjohn (proofreading for errors). Loretta seconded. Motion carried.

Loretta made a motion to approve the Private Sector Resolution #4-6-83-A. Lloyd seconded. Motion carried.

TRIBAL PROGRAMS

Gordon made a motion to give Lloyd the authorization to put a narrative of Tribal programs to be published in the Kalihwi-saks. Lois seconded. Motion carried.

RADIOACTIVE WASTE MEMO

Lois made a motion to send the Radio-active waste memo to other Tribal representatives that generally states, " On April 20, 1983 at 10:00 A.M. the Oneida Tribe will host a Wisconsin Radioactive Waste Review Board meeting at the Sacred Heart Center. The Review Board is designated as the state entity that will deal with the Department of Energy on the high level radioactive waste repository issue. The meeting will begin at noon at the Sacred Heart Center in Oneida. Prior to the Review Board meeting, Oneida Tribal representatives may wish to meet with other Tribal representatives. This meeting would be held to discuss Tribal concerns over this issue and to explore various courses of action. Lois seconded. Motion carried.
