FINANCE & APPROPRIATION RECOMMENDATIONS

Loretta Metoxen moved to approve of Recommendation No. 1 to approve expansion of Oneida One Stop for additional storage space to come from Capital Improvements line item in General fund budget. Seconded by Kathy Hughes. Discussion on request. Tony Utschig came into meeting to explain. Questions on purpose of storage space being adequate, insulation required, etc. Tony explained this was purely a temporary measure as they were not sure what the addition would be permanently used for. It will be for storage of pop and cigarettes for now. Lois Powless abstained. Motion carried.

Mark Powless moved to approve of recommendation #2 to pay ICW Board stipends with funding from General Fund Special Projects. Lloyd Powless seconded. Motion Carried.

Lloyd Powless moved to approve of recommendation #3 to appropriate \$2,000 for Super Summer Session from General Fund Special Projects. Kathy Hughes seconded Motion Carried.

Lloyd Powless moved to approve of recommendation #4, for approval of Public Transit #55603 modification showing Tribal Contribution of \$3,340 which is already approved in the General Fund. Lois Powless Seconded. Motion Carried.

TRAVEL REQUEST

Questions on travel request for Norbert Hill to travel to the 8th Annual Indian Law Conference, on April 14-15, 1983 in Phoenix, Arizona presented by the Indian Law Committee of the Federal Bar Association. Jerry Hill had originally requested a Business Committee member to accompany him but no mention was made when his travel was approved. Loretta Metoxen moved to approve Mark Powless seconded. Motion Carried.

MOUNT SENARIO

Kathy Hughes moved to approve the letter of support for Mt. Senario College Social Work Sequence Program and Reservation Based Outreach Classes. Lois Powless seconded. Motion Carried.

CREDIT CARDS

Kathy Hughes stated that the application for credit cards was going through and it would take approximately two weeks before it would be final.

Norbert Hill moved to recess, Kathy Hughes seconded. Motion Carried. Meeting recessed at 9:45 A.M.
