## LETTER TO IHS - Tony Benson

Mark made a motion to send the following letter to Mr. Richard McCloskey, Director Office of Legislation and Regulations Services, IHS, via telegram:

"Mr. McCloskey,

The Oneida Tribe of Indians of Wisconsin has been very conscientious in collecting third party billings. The insurance companies that refuse to pay, citing that Indians are not financially responsible for services are minimal. If state statutes and Federal legislation required insurance companies to pay, that problem would no longer exist. The Oneida Tribe does not agree that the use of fiscal agents to process claims will reduce I.H.S. Costs nor will it increase revenues.

The Oneida Tribe is practicing Indian self determination and any change in Federal regulations must have considerable input from the Tribes. We are requesting that no action be taken until that has been done. We are very concerned about the services for our people and any changes in that service."

Kathy seconded. Motion carried.

## TRAVEL REQUEST BINGO TASK FORCE MEETING IN MINNESOTA - Jerry Hill

Jerry Hill requested to travel to Minnesota to attend a Bingo Task Force meeting on August 18, 19, 1983. Kathy made a motion to approve. Loretta seconded. Oneida Tribe of Indians of Wisconsin Special Meeting - August 15, 1983 Page 2

Motion carried. Kathy also included in her motion that Mark, Gordon, and Jerry leave earlier to attend the meeting with the Bureau of Indian Affairs. Loretta seconded. Motion carried.

## JUDY MCDANIEL REQUEST FOR \$400. - Lloyd Powless

Lloyd presented a following request: Ms. McDaniel is a graduate of the Institute of American Indian Arts and a candidate for the Museum Board. Ms. McDaniel is requesting support for expenses. She has a round trip ticket from Chicago to Albuquerque, N.M. She requests additional expenses for meals, rented car and lodging. The approximate cost would be \$400.00. Discussion followed concerning setting up an emergency funds for these types of requests in the future. Loretta made a motion that this request be referred back to Finance & Appropriations Committee for immediate action. Rick seconded. Tony and Mark abstained. Motion carried.

- 4. 83-217 Records Management (Museum) This was referred back to the Museum Director, Bob Smith for further analysis on line item changes.
