






UGWA DENOLUH YATEHE

FINANCE & APPROPRIATION RECOMMENDATION (MEMO OF AUGUST 25) - Kathy Hughes

- 1. 83-225 Public Transit submitted a budget modification to purchase tires for the bus. No tribal contribution needed. Kathy made a motion to approve. Loretta seconded. Motion carried.
- 2. 83-226 Cannery has submitted a budget modification and needs an additional \$1,000 for increased costs in fringe benefits. Money is available in the General Fund. Tony made a motion to approve the recommendation. Mark seconded. Motion carried.

- 3. 83-227 Materials Development Proposal requests a tribal contribution of \$11,715.00 This budget is part of the Fy 84 budget consideration. Funds available in 84 General Fund. Tony made a motion to approve the recommendation. Kathy seconded. Motion carried.
- 4. 83-228 Oneida One Stop has submitted three bids for storage tanks. Their recommendation totals \$14,755.00. No action taken. (Tabled)
- 5. 83-160 Amend. #2 An additional \$1,292.00 is requested for the new drapes at the Nursing Home. This additional request is due to measurement miscalculations. Money is available in the General Fund. Mark made a motion to approve the recommendation. Tony seconded. Motion carried.
- 6. 83-230 Building & Grounds has requested \$1,627.00 to repair basement leakage at the Tribal Building. Money is available in the General Fund Loretta made a motion to approve the recommendation. Lloyd seconded. Motion carried.l
- 7 83-231 The Utilities Program wishes to establish a reserve account for future painting of the Water Tower and replacement of equipment as it wears out. They wish to have \$12,000 set aside in a special account to address these needs. A letter is to be sent to Barbara Hill-Hawkins and to inform her that this would come under Capital Improvements.

PURCHASE OF BANK STOCK - Kathy Hughes

Kathy wishes to request authorization to purchase the 124 shares of State Bank of DePere common stock at \$66.00 per share stating that she had researched the minutes and has not been able to determine an authorization for more than the original shares purchased. The long-term investment category has \$68,000.00 remaining in the line item.

MEETING W/PROXMIRE'S AIDE IN RHINELANDER CONCERNING INDIAN HEALTH - Tony Benson

Tony met with Senator Proxmire's aide, Larry Patton. Larry has been reviewing the Indian Health Clinic's in the state and wanted to see first hand what the Indian clinics has so that he may gain a better understanding of the Health Center operations.

PROSPECTIVE PURCHASE OF VERNON/JOY NINHAM HOME - Loretta V. Metoxen

Those present at the negotiating session on August 25, 1983, were Chris Doxtator, Ben Vieau, Rick Hill in place of Kathy Hughes, and Loretta Metoxen.

The asking price was \$65,000.00 The negotiating committee offered \$56,000.00. The Ninham's immediately made a counter offer of \$58,000.00 in a written statement.

The recommendation from the Negotiating Committeee was to purchase the Ninham home (duplex) at \$58,000.00 for purposes of two (2) rental units. Tony made a motion to approve the purchase. Lloyd seconded. Mark abstained. Motion carried.

BROWN CTY/OUTAGAMIE CTY FORMATION OF A TASK FORCE TO INVESTIGATE THE RIGHTS OF THE TRIBES
