CHAPTER I PROPOSAL

Questions on job descriptions, parent participation and School Board participation, etc. Rick Hill moved to approve the Chapter 1 Proposal. Lloyd Powless seconded. Rick amended his motion to include that a letter requesting some type of waiver to be effective July 1, 1983 be included. Motion Carried.

Bill also discussed the meeting with the School Board and the revisions to the proposed revision of the Oneida Tribal Management System to reflect the school boards responsibilities because of the Memorandum of Agreement with the Oneida Tribal School Board. Bill also requested that someone from the Business Committee contact Bureau Of Indian Affairs regarding Joe Moony not contacting them. The Business Committee could possibly request that he be requested to comply with this request.
