430-WOODCUITING RECOMMENDATION

A moratorium on all woodcutting occurred on March 18, 1983 by directive of the Business Committee. Woodcutting Interim Procedures were presented by Loretta Metoxen and Lois Powless: 1) Rosemary Gregor will familiarize herself with the woods on site tours with Herman Melchert and CLayton Cornelius. She will also post a map with appropriate coding. 2) Herman & Clayton will use chain saws. Helpers will do other things, such as trimming, piling and loading.

3) Three standard prices will be set for a face cord depending on: a. SSI or similar income (Senior Citizens) b. Increased paying capability (Senior Citizens) c. All other Tribal Members. 4) Only dead and down trees will be cut to adequately "clean up" certain areas. The airport parcel may be an exception. 5) A monthly report will be developed by Rosemary, signed by Herman for the Business Committee and the Land Committee. This is an interim measure intended to address the immediate needs of the Senior Citizens.

Mark moved to approve the recommendations. Gordon seconded. Motion carried.
