270-ACTIVITY DIRECTOR AT ONEIDA NURSING HOME - Tony Utschig

Tony Benson requested Tony Utschig to explain why the Activity Director position at the Nursing Home had not been filled. Also, what type of action has been taken to insure that the lateness of filling these types of positions will not happen again in the future as there is a possibility of a fine being imposed on the Oneida Nursing Home. The following memo was given to the Business Committee of the activities that occurred in refilling this position:

"On October 18th, Rick Johnson received a resignation from the Activity Director. This resignation and a job description were sent to Dale Wheelock on October 19th. Dale received the information on October 20th, had the job description retyped on Friday, October 21st, and posted on Monday, October 24th for internal promotions.

An application for internal promotion was received by the October 31st deadline. This applicant had some good qualifications for the job but there were questions as to whether the applicant met the guidelines of the State. Rick Johnson requested a ruling from the State regarding whether this applicant could be hired for the position. He received an answer on November 8th that this applicant could not be hired for the job. Dale was then notified on November 9th that this applicant could not be hired.

Because of a heavy workload due to staffing problems at Personnel, this job was erroneously not externally posted until three (3) working days later on November 15th. This delay did not slow up the hiring process however, because of our requirement that all jobs be posted in the Kalihwi-Saks.

270-Activity Director (Continued)

An ad has been placed in the Kalihwi-Saks, Press Gazette, Post Crescent, and Milwaukee Journal advertising this position. Qualified applicants are being received. An applicant should be hired in late November to start no later than mid December.

In regard to potential fines, whenever we have a vacancy in a key position the State Division of Health Services must be notified of the vacancy. We must then make a good faith effort to refill the position. Rick Johnson had performed his duty and notified the Green Bay Division of Health Office. In speaking with Rick in regard to making a good faith effort, he sees no problems with our compliance with this rule and has informed me that we are not in danger of being fined or penalized for our actions."

Tony Utschig was told that he and his staff were to make every effort to keep the Nursing Home from getting into a potential fine situation and to review the procedures for qualifications for internal promotions so that does not happen in the future.

220-NEW YORK LAND CLAIMS DISCUSSION - Arlinda Locklear, Jack Campisi, Reginald Horseman, Francis Skenandore, Jerry Hill

Arlinda explained the situation on the following:

Oneida Indian Nation vs. County of Oneida, 70-CV-35, also known as the test case or Judge Port's case. This case, which challenges the 1795 transaction between the Oneidas and New York State, is the only eastern land claim to go to final judgement. The counties appealed the judgment in favor of the Oneidas and, last month, the Second Circuit Court of Appeals affirmed the favorable decision. The Second Circuit also determined that Judge Port had not awarded the Oneidas enough trespass damages and sent the case back to him so that the damages can be recomputed. The Counties can ask for Supreme Court review of the Second Circuit's decision. The Counties' petition to the Supreme Court is due the end of December. The whole process (the briefing, argument and decision) would take approximately six-nine months.

Oneida Indian Nation vs. County of Oneida, 74-CV-187, this case challenges all the other post-1790 state treaties by which the Oneidas lost its whole 252,000 acre reservation. This case is also pending before Judge Port, but nothing has ever been done in the case. Because the legal issues in it are the same as those in the test case, the Judge decided to just let it sit until the test case is over.

Oneida Indian Nation vs. State of New York, 79-CV-798, It challenges the two pre-1790 transactions and seeks eviction of 60,000 property owners from five million acres. Judge McCurn dismissed this case as not being valid two years ago and last October the Second Circuit court of Appeals reversed and sent it back to Judge McCurn for trial.

Since the case has been back before Judge McCurn, he has at our request

disqualified Tim Coulter from representing the Thames Band (because of the conflict of interest between the Thames Band and the Confederacy) and denied the Six Nations motion to intervene (partially because the Six nations claim against the Oneidas). Both the disqualification order and the denial of the motion to intervene have been appealed by Coulter. Arlinda expects a decision out of the Second Circuit on the first issue by the end of January 1984 and on the second issue approximately April 1984.

Judge McCurn also scheduled trial in the case for January 30, 1984. We have asked that the trial be delayed for four months so that our experts will be out from under their academic responsibilities.

There was discussion on the beginning of opening up negotiations with the State of New York.

Loretta Metoxen made a motion to authorize Jerry Hill and Francis Skenandore to begin working out plans with Arlinda for negotiations with the State of New York. Gordon seconded. Motion carried.
