- 1) Green Bay Human Rights Commission: The Commission has invited someone from the Tribe to their meeting on January 27, 1984. Jerry will work on a draft statement and bring this in for review before January 27, 1984.
- 2) Public Meeting w/Arlinda Locklear: Mark made a motion to have Loretta Metoxen set up a meeting with Arlinda Locklear to give an update on the New Land Claims here at the Sacred Heart. Rick seconded. Loretta abstained. Motion carried.
- 3) Meeting w/BIA in Washington, D.C. on January 18, 1984 concerning the City of Green Bay appeal--23.5 acres: The points discussed were:

220-INDIAN STUDY COMMITTEE - Sharon Cornelius



Mark made a motion to have the Oneida Tribe support the recommendation for the protection of the Indian burial grounds and that Sharon Cornelius continue to work with the Committee on this project. Rick seconded. Motion carried.
