#### 250-RECOMMENDATION FOR THE WISCONSIN CONSERVATION CORP. PAYROLL - Bob Christjohn

There were two reasons why the payroll was not to Oneida by the Department of Natural Resources: 1) The time sheets had been sent to the wrong DNR office; this has been cleared up. 2) The DNR does not have the payrol1 paperwork in their office yet. The paper work was mailed twice to them. The second time it was sent certified mail.

Because of the problems, the payroll coming from the DNR will not be here in time for the release of the pay checks. Bob is recommending we use the existing WCC Budget to meet the payroll which is \$2,200 and when the employees receive the pay checks from the DNR they will reimburse the Oneida Tribe.

Mark moved to approve the recommendation. Lloyd seconded. Motion carried.

### 080/160 - JTPA MERGER RECOMMENDATION - Bob Christjohn

Bob is recommending that the JTPA be merged with the Higher Ed Office under Ron Skenandore's direction. Bob is also recommending that there be changes in the job responsibilities and salaries.

Lloyd made a motion to approve the merger and that if there are any salary adjustments, they be justified in the FY 85 budgets.

## 070-CANNERY BY-LAWS - Jerry Hill and Carol Elm

Lloyd moved to approve the Cannery By-Laws and adopt Resolution #6-15-84-A. (See attached report) Gordon seconded. Motion carried.

## 220-TRIBAL ALCOHOL POLICY - Jerry Hill

Resolution #6-15-84-B states that all activities conducted or supported by Tribal resources, directly or indirectly, shall not include the sale of alcohol in any form or manner with the exception of the Oneida Hotel Project.

Mark moved to adopt Resolution #6-15-84-B. Lloyd seconded. Motion carried.

# 110-REQUEST FOR SOIL BORINGS FOR THE HOTEL SITE \_ Bruce King & Carl Rasmussen

There was a question as to whether the Tribe should go ahead with the borings before we get any notice of the UDAG Grant. Bruce feels we should approve the borings now because it will save alot of time down the road. We may still be able to get the cost covered once we get the UDAG Grant. The cost is between \$3,605.00 and \$4,405.00.

Rick moved to approve the soil borings for the hotel site. Kathy seconded. Motion carried.

# 020 - BAY-LAKE PLANNING COMMISSION OEDP - Carl Rasmussen

EDA required that the Brown County OEDP Committee endorse the Sewer & Water Project with Ashwaubenon before the Tribe's application for funds would be processed further. This is because the project was outside the Reservation Boundary. Although the project was not specifically listed, it appears Carl will be able to get the endorsement.

Mark made a motion to have the Law Office review Bay-Lake Regional Planning Commission and comment on the Tribe participating in their overall Economic Development Planning Process. What contract relationship would have to be worked out with Bay-Lake to recommend a member.

Gordon seconded. Notion carried.

#### 060-PROPOSAL FOR YOUTH ALDS FUNDS

The Oneida Tribe's Human Services Support Group is a group or concerned community people from various human service agencies in the Oneida and Green Bay urban area, serving the Native American population. The group meets weekly and discusses areas of concern of the community. A Group Home is one, if not the major concern, expressed by the group. The group also understands that to pursue such a home will require full time commitment by one or two people.
