The Native American Church requests wood for sweats and other uses. They want "FREE" wood. The Land Committee recommends they remove the dead and down trees behind (east) of County Trunk "U" with monitoring from the Commission.

Tony moved to deny this request. Nobody seconded. Loretta moved to send this recommendation back to the land Committee to get the amount of wood that will be taken out. Kathy seconded. Gordon abstained. Motion carried.
