#### 060-BUSINESS COMMITTEE ACTION OF SEPTEMBER 7, 1984

Regarding the hiring of Douglas Kindness for the position of Education Counselor (Home School Coordinator)

Dale Wheelock brought a request of reconsideration on the action of September 7, 1984 involving action to go to the second choice of Douglas Kindness for the position of Education Counselor (H.S.C.). The action taken is in conflict to the Tribe's Policy Statement of Equal Opportunity Employers and possibly the General Tribal Council Resolution of 2-25-82.

The Education Counselor (Home School Coordinator) position came before the Business Committee as information on September 7, 1984, at which time action was taken to go with the second choice. At that time, the question of whether the 1st choice was an Oneida or not was raised. Dale's response was no and that Grace Wills was a Chippewa but was most qualified for the position due to her years of experience. Action was taken to go with the second choice. This action places the Personnel Office in a precarious position of interpreting an action that is contrary to the Oneida Tribe's Policy Statement of being Equal Opportunity Employer. The attached Policy Statement clearly states the most qualified individual, and when all qualifications are equal between applicants Oneida Indian preference is to be implemented. The Personnel Office requests documentation that action taken was warranted in that it is the Personnel Director's responsibility to maintain the Tribal employment policies.

The Personnel Director requested a discussion and interpretation of Oneida Business Committee involvement in Personnel decisions for the Oneida Tribe. The Law Office assistance in the interpretation would be appreciated. Dale requested discussion in establishing a mutual interpretation of the 2-25-82 Resolution there by eliminating the gray area where misinterpretation can occur

Lloyd made a motion to recind the action of September 7, 1984 of going with the 2nd choice and approve going with the first choice who is Grace Wills. Kathy seconded. Tony and Lois abstained. Motion carried.

Tony moved to send material explaining any changes made on the Personnel Selection recommendation to the Personnel Office. Kathy seconded. Motion carried.

Kathy made a motion to have the Personnel Director review the Management System and point out any portions that are in conflict with the General Tribal Council Resolution of 2-25-82. Gordon seconded. Motion carried.

#### ETTER TO DR. ROADES

Enclosed is a copy of a resolution passed by the Oneida Tribe of Indians of Wisconsin Business Committee and submitted to the National Congress of American Indians.

I wish to affirm the sentiments contained in this resolution to you, as Director of Indian Health Service. I do not support the transfer of John Buckanaga, IHS Bemidji Area Director to another area due to the disruption in the continuity of health services that I believe would result from such a transfer. Mr. Buckanaga has become familiar with the health needs of the Oneida Tribe and has expressed a commitment to assist us with specific problems and concerns that are unique to our Tribe and we do not foresee any benefits for the Oneida Tribe in such an arbitrary transfer; and respectfully ask that you reconsider your decision and allow Mr. Buckanaga to remain in the Benidji area.
