#### 165-HIP RECOMMENDATIONS - Jerry Kurowski

Jerry submitted the last two (2) applicants for HIP for fiscal year FY '84. The work on these two projects must be completed before October 30, 1984.

1) Sylvester Smith - Category A (Disability) - Lumber and materials to repair and remodel mobile home and weatherization for winter. There will be an account set up a Schaumann Lumber not to exceed \$2,500.00 Sylvester will pick up the material as needed.

Dave moved to approve the recommendation. Tony seconded. Motion carried.

2) Alexander Parkhurst - Category B (Elderly) - Repair roof, repair entrance and build addition for utilities due to freeze up problems. This task would be done by Schaumann Lumber at a cost not to exceed \$4,500.00.

#### 010-FINANCE & APPROPRIATION RECOMMENDATIONS

Three (3) bids were submitted for a purchase of a 1984 pick-up truck for Building & Grounds. Mark moved to approve the purchase of the 1984 Ford Truck from Woody Jepson at a cost of \$8,694.00. The funds are to come from Revenue Sharing. Dave seconded. Gordon and Tony opposed. Motion carried.

#### 010-INDIRECT COST PROPOSAL - Lynn Horsens

There was discussion on the due date of this proposal. The due date was in April. An earlier request was to move this back until August, but the proposal was not finished until this week. Lynn did not specify any reason for the lateness of the proposal. John Telfer, Tribal Controller is on sick leave at this time.

Lloyd moved to approve the Indirect Cost Proposal for FY '85. Gordon seconded. Mark abstained. Motion carried.

Lloyd made a motion to request that John Telfer prepare a report explaining the reason for the lateness of the proposal. The report is to given to the Business Committee one week after John returns to work. Tony seconded. Motion carried.

#### ERNST & WHINNEY PROPOSAL UPDATE - Bob Archiquette/Mark Powless

Mark requested the Business Committee to review the report and that he will place this on the agenda at a later date for further discussion.

#### 120-RENOVATION OF FOOD DISTRIBUTION WAREHOUSE - Dale Powless

Dale stated that there is an urgent need of space as they expect to receive three (3) months supply of food within the next 2 to 3 days. At present they do not have enough space unless they do some renovation or rent space elsewhere until the renovation is completed.

Three bids were received:

Iroquois Construction Corp., Available immediately at a cost of \$2,306.87.

Schaumann Lumber Co, Available 2 to 3 weeks at a cost of \$1,742.00.

Seymour Lumber, Available 2 to 3 weeks at a cost of \$1,020.00. (Electrical work not included)

Dave moved to approve the request as they are available immediately. Lloyd seconded. Tony and Gordon opposed. Motion carried.

#### 340-RECREATION BUDGET

The Business Committee reviewed the action taken on September 28, 1984 in regard to the salary increases of the Recreation staff, which was that the Recreation staff would remain at the 1984 wage level until the 1985 budget is approved and then it will be dealt with retroactively. After discussion, Lloyd made a motion to rescind the action that the wages remain at the 1984 level and directed that Recreation staff wages be processed along with the remainder of the tribal employees. Tony seconded. Motion carried.

The DNR requested a meeting the tribal members to discuss their concerns. Rick Hill will follow up on this request.
