VOTE REGISTRATION DRAFT - Loretta V. Metoxen

During the discussion on the request it was brought out that there are other requests that have come to the Business Committee for funds. It was agreed that all requests should have consideration.

Mark made a motion to refer this request to Finance & Appropriations and that the Treasurer take into consideration all future requests, and to bring this item back on the Agenda on October 19, 1984. Kathy seconded. Gordon abstained. Motion carried.

150-REFUSE SERVICE - Lois Powless

With the closing of the Refuse Service provided by the Tribe, other companies were requested to submit bids to provide refuse service for the tribal programs and enterprises.

Four (4) companies submitted their bids. After checking out these companies, Lois recommended Brown County Sanitation Service. The company is co-owned by a tribal member.

Mark moved to approve the bid from Brown county Sanitation Service. Kathy seconded. Kathy moved to amend the motion that when the contract is drawn up that there be a thirty (30) day termination clause in the contract. Dave seconded. Vote on the amendment carried. Vote on main motion carried.

HEALTH BOARD MINUTES

Lois moved to approve the Health Board minutes of September 24, 1984. Kathy seconded. Mark abstained. Motion carried.

060-TRAVEL REQUESTS

Purcell traveled to Washington, D.C. on October 4, and 5, 1984 regarding the hotel project. Retroactive approval is needed for this trip. Mark moved to approve. Kathy seconded. Motion carried.

The discussion items are: Legal Representation of GLITC; Continuation of Tribal Nutritional Programs and Bingo Pull Tabs. The meeting is scheduled in Duluth, MN on October 17, 1984. The third travel request is to attend the televised panel discussion on treaty rights and tribal sovereignty in Merrill, WI on November 1, 1984 at 7:30 P.M.

Dave moved to approve Jerry's travel requests. Tony seconded. Gordon abstained. Motion carried.

REPRESENTATIVE TO GLITC MEETING

Rick will not be able to attend the GLITC meeting in Duluth on October 17, 1984 and has appointed Lois Powless to be the tribal representative for this meeting.

220-BINGO ORDINANCE - Jerry Hill

Jerry presented a draft on the changes to the Bingo Ordinance. The Business Committee reviewed the draft and recommended some changes. The Law Office will bring back the redraft of the bingo ordinance on October 16, 1984 for review.

DISCUSSION ON BILL 456

Purcell was contacted by Joe Delacruz from Washington State to ask for support in defeating this Bill. Bill 456 is an effort to overturn the 1974 Boldt Decision on Treaty fishing. It will be placed to the ballot in Washington State for the November election. They are trying to raise \$300,000.00 to pay for TV and press coverage to defeat 456. This is just a beginning of the back lash building. They requested \$10,000 from each of the Wisconsin tribes.

Lloyd moved to table this request until after the GLITC meeting on October 17, 1984 to get comments from the other Wisconsin tribes. Lois seconded. Mark abstained. Motion carried.

REPORT ON STAFFING TO COVER HEALTH CARE AT ONEIDA HEALTH CENTER - Tony Benson

Tony stated that he had checked with the Health Center Director, Barbara Hawkins and that during the absence of Dr. Craig the workload would be adequately covered. Dr. Thompson is working on her schedule so that she can meet with the Business Committee on October 16, 1984 at 1:00 P.M.
