### 210-TABLED TITLE VII LANGUAGE PROPOSAL - Amelia Cornelius

This item was tabled because Amelia was out of town and there was a question on how this program would relate to the present program.

Amelia explained that this project would be designed to provide a special supplementary program of Bilingual education to Indian children, three to six years of age, such as: Tribal Early Childhood, Headstart and Tribal School Kindergarden. It also provides intensive parental/family based bilingual training. If funded, a Tribal contribution of \$16,865 would be needed to have total budget of \$182,404.

Kathy moved to approve. Lois seconded. Motion carried.

#### TABLED BID FOR SNOW REMOVAL

This item had been tabled because there was only one bid. Three bids were submitted. Two more bids have been submitted.

## TABLED FY85 PRIORITY EXPENDITURES FOR NORBERT HILL CENTER - Yvonne Jourdan

Rick moved to take these items from the table. Lois seconded. Motion carried.

- A New Roof Over The Central Wing: Mark moved to approve the re-roofing of the main building at the Norbert Hill Center and Kloiber and Hofman as the architects. Their firm will provide working drawings detailing the scope of the work to be done on the re-roofing. They will also provide bidding documents and award the work to the successful bidder for the project. Once the construction has commenced, they will supervise the work being done. The construction cost will not exceed \$50,000.00 and their fee will be 6% of the construction cost.

Kathy seconded. Lois opposed. Motion carried.

Kloiber will also apply for a grant for a reimbursement from the state for these repairs.

Rick moved to approve the procedural exception to have Kloiber and Hofman expedite the needed repairs on the roof repairs because winter is fast approaching. Tony seconded. Lois opposed. Motion carried.

New Signs for the Norbert Hill Center: Yvonne had a bid ranging from \$1,000 to \$5,000 for the cost of the new signs.

Mark moved to approve the bid. There was no second. Motion dies.

Yvonne was requested to bring a more specific cost rather than a range of \$1,000 to \$5,000. There was also discussion of a Tribal Symbol that would be put on the signs.

- License Application For the Bakery: Kathy moved to table the request for a bakery license until a review was completed by the Law Office. Lois seconded Motion carried.
