REVIEW OF LETTER FROM COUNCIL OF ENERGY RESOURCES TRIBES - Lloyd Powless

The Council of Energy Resource Tribes (CERT) has received support from the United States Environmental Protection Agency (EPA) to conduct a survey of potential hazardous wastes problems on selected Indian Reservations in the country. Because of the Oneida Tribe's interest in protecting the reservation environment, the location of the reservation with regard to possible hazardous waste sources, or activities and/or other information indicating potential problems on the reservation, Oneida is being requested to participate in this study.

In addition to the obvious benefits of having an assessment of hazardous wastes on our reservation, the Oneida Tribe will be participating along with 24 other tribes to develop a model approach to defining hazardous waste issues for all the remaining tribes in this country.

They are requesting that the Oneida Tribe designate a tribal contact person for them to work with. This person will assist in the accumulation of data from the reservation, and will serve as a representative on tribal working group being formed to assist in conducting this study.

Kathy moved to have Lloyd as the contact person to work with CERT and Lloyd will keep John Spangberg abreast of the activities with CERT because of John's work with the Fort Howard Sludge Pond. Rick seconded. Mark opposed, Lloyd abstained. Motion carried.
