## REVIEW OF THE JUDGEMENT CONFERENCE - Jerry Hill

Jerry explained, under the present ordinance, if there is more than one judgement, each would be susceptible to 20% and could create a hardship. There is also an Administrative Procedure for Garnishment and Payroll Deduction that has been attached to the certified ordinance which has not been adopted. Notice should go out to all Directors that this is not an official document and should not be followed.

The Law Office recommends that each case be reviewed with the Law Office prior to the actual hearing. Jerry will send the Business Committee a follow-up memo on this subject.

## RESOLUTION 5-7-85-A: CONCERNING THE 23.5 ACRE SITE WITH THE CITY OF GREEN BAY - Francis Skenandore

This resolution is stipulating that the Tribe and Housing Authority agree to extend the terms of the cooperation agreement for the 10 acre site (Benson Property) to the 23.5 acre parcel.

It is understood that the resolution is only a condition on the Tribe for the land going into Trust and if the offer is rejected by the City, it has no effect on the Trust status.
