UPDATE/SITE ALTERNATIVES FOR TRAILER PARK - Larry Barton

There are two potential sites which are both near the Site II Lagoon Treatment facility. The lagoon treatment facility can be upgraded to serve the 25 unit Trailer Park. Indian Health Service has committee \$200,000 to the project.

Option A: Would have a total cost for sewer/water hookup and lagoon renovation of \$240,000 with a \$40,000 Tribal Contribution.

Option B: Would have a total cost for sewer/water hookup and lagoon renovation of \$330,000 with a \$130,000 Tribal Contribution.

After review of the location of the Trailer Park, Kathy moved to refer this item to the Business Committee Land Sub-Committee to work with Larry Barton on the suggestions made during the review. Gordon seconded. Motion carried.

BURIAL SITE LEGISLATION - Jerry Hill

Jerry presented a summary of the proposed legislation regarding cemeteries and burial sites on Indian Reservations. Jerry recommended that the Business Committee consider drafting an ordinance that would regulate the cemeteries and burial sites on our reservation.

Kathy moved to refer this item to the Ordinance Sub-Committee. Gordon seconded. Lois opposed. Motion carried.
