LAND COMMITTEE RECOMMENDATIONS OF AUGUST 26, 1985

1. The Land Committee recommends that the Rose Skenandore Property be advertised for rent with option to purchase. The purchase price is to be \$32,000. Rental per month to be \$250.00 (plus security) 1/3 of monthly rent to go towards purchase. Rental period to be 6 months. 10% down at the end of rental period. Property to be advertised from September 1 to September 23, 1985.
