AIR MONITORING (CONTINUED)

Kathy moved to approve Resolution #11-15-85-A and the letter to Kestutis Ambutus of E.P.A. which are as follows:

Resolution #11-15-85-A: The Oneida Reservation is located near the heaviest industrialized area in Wisconsin and,

Air quality on the Oneida Reservation may be affected by the nearby industrial activity, and

Indian Tribes have the legal right to regulate air quality on reservations, and

E.P.A. and the Council of Energy Resource Tribes (CERT) have made funding available for development of air quality regulations.

NOW THEREFORE BE IT RESOLVED: that the Oneida Tribe supports the development of preliminary air monitoring regulations for the Oneida Reservation by EPA and CERT.

Letter to K.C. Ambutus:

Attached is a resolution, passed by the Oneida Business Committee supporting the joint Oneida, E.P.A. and C.E.R.T study and development of air quality regulations for the Oneida Reservation.

The Tribe is looking forward to working with the E.P.A. and C.E.R.T. on this project.
