REQUEST FROM LEON COOK RE: Indian Movie

Mr. Cook was requesting financial support for the making of a movie titled "The Savage American". Leon Cook is working towards raising 2.5 million dollars for the movie and he is asking the Oneida Tribe to participate with any amount that would be comfortable. Mr. Cook stated that he feels this is the most effective way to tell the story of the Indian People. It would be seen through the media of film in theaters, on T.V., on video cassettes throughout the world.

After discussion it was agreed by the Business Committee couldn't participate now because of other priorities and a letter would be sent to Mr. Cook explaining the Tribe's situation.

DISCUSSION ON SPECIAL FUND FOR LITTLE BEAR & TONY MERRIL (Per Memo of January 14, 1987) - Mark Powless

The Business Committee discussed various ways in trying to help Little Bear and Tony Merrill. They are both Oneida children with terminal illnesses. Mark Powless moved that the Health Expansion Fund be explored and that the following two suggestions be approved.

- One Saturday Night Session of bingo: Have the entire session donated to these two families to be divided equally. Also, a special game at that session. That game itself would pay out \$500 and whatever is taken in would go towards the benefit fund. This particular game should be planned out far enough in advance so it can be advertised properly. Charlie Leonard of the Public Relations Department should be contacted to work on this. Also, the public relations and media can be tied into a solicitation of funds for these two benefits.
- 2) Sandy Ninham uses Sunshine Travel Agency. See if they can donate three tickets for the Little Bear family to go wherever they want and two tickets for the Merrill family (they travel back and forth from the hospital). If they can't donate it all perhaps they will allow some type of discount.



SPECIAL MEETING

JANUARY 20, 1987

Meeting called to order at 10:00 A.M. by Chairman, Purcell Powless.

Meeting with Representatives for HI-IMPACT: Alan Fabian - Dave Grendados and Ken Lehman.

Alan Fabian showed a video titled "The New Capitalist Economics in Indian Country". This told what other Indian Tribes are doing in economic development.

After the video, two areas were discussed: 1) A joint venture with existing corporations which could locate a plant on the Oneida Reservation, and 2) Discussion on tax free non-recourse revenue bonds.

After discussion, the posisble joint ventures and the revenue bonds, Al Fabian requested tribal representatives accompanying him to visit the Methode Electronics Inc., in Chicago, IL., to view their operation. They are engaged in the production of switches and controls for the automotive industry. Methode Electronics are interested in doing business with an Indian Tribe on a joint venture. The Business Committee agreed to send John Powless and Dave King with Al Fabian to visit the Methode Electronics firm. Al Fabian also requested that the Tribe contract with his company HI-IMPACT as primary consultants and representatives for the Tribe in matters that pertain to joint ventures and revenue bonds. The Business Committee told Mr. Fabian that they would look at what his company had to present on a item by item basis, but would not enter into a contract.
