TUESDAY, MARCH 3, 1987

Lloyd Powless moved to adopt the agenda, Mark Powless seconded. Motion carried.

INTERFAITH TASK FORCE - Reverend James Putman

Reverend Putman explained that there is a great deal of concern from both Indian and Non-Indian about the future relations between the two communities. Especially on the Reservation Boundary Suit. There has been discussion on developing an interfaith task force to explore the various avenues for understanding and better relations. The following is a tentative list that the Interfaith Task Force would be looking at:

- 1. To identify the sources of current antagonisms and/or prejudices on the part of the Oneidas and non-Indians.
- To understand the implications for the total community of the 1838 Treaty with the Oneidas.
- To identify the concerns and fears of the non-Indian community and the 3. Indian community.
- To identify the common concerns of the Indian and non-Indian communities.
- To explore avenues of communication and understanding between the Tribe and the non-Indian community.
- To identify the strengths within the Indian and non-Indian communities upon which we can build.
- 7. To structure vehicles for creating understanding and cooperation between the communities.

Reverend Putman wanted to inform the Business Committee on the development and direction of the Interfaith Task Force.

453-ONEIDA NURSING HOME CONCERNS - Whitney Mills

The amount of sick time, especially on weekends is the problem Whitney Mills wanted to discuss with the Business Committee.

Whitney Mills requested that the Business Committee consider making a change in the sick leave policy. The Business Committee discussed the problems and changes that are being considered. The two main points covered were changes in the sick leave policy and changes for enterprises hiring, which includes the nursing home.

Whitney will also submit recommendations to the Business Committee that would help his operation at the Nursing Home. At the present time there is a sub-committee working on the revision of the Policies and Procedures for the Tribe.

351-UPDATE ON THE HOTEL - Janice Hirth

Janice Hirth explained that during January, the General Manager, Food and Beverage Manager, Waitress and Banquet Manager, and the Front Desk Manager have been changed, because the handling of the Hotel has not been up to the satisfaction of the Oneida Airport Hotel Corporation. The Indian employment had dropped to 45% and is now up to 59%. Lodging Systems Management has been put on notice to make necessary improvements. In the mean time, the Hotel Board is looking at other management companies in case things don't work out with Lodging Systems Management. With all the problems in the management area, the Hotel is still getting positive feedback from the majority of the customers.

Although the detailed agenda is not finalized at this time, preliminary plans include a dinner, Social Dance, getting acquainted and "settling in" on Friday evening. Saturday, morning would be a briefing on the New York Claims given by attorney, Arlinda Locklear of NARF and other attorneys representing other Oneida communities. The Attorneys will then leave and the rest of the day will be reserved for discussion by the Oneida people to arrive at a common understanding of legal and all other issues relating to the pending New York Claim of the Oneidas.

Sunday a tour of the reservation will be available.

The Oneida Tribe of Wisconsin will provide dinner on Friday evening and lunch on Saturday and Sunday for everyone.
