Dave King moved to adopt the agenda, Lloyd Powless seconded. Motion carried.

452-TEMPORARY USE OF THE FORMER CARLTON PROPERTY - Carl Rasmussen

Vinton Construction asked for the temporary use of the Carlton Property for the period of April 1 to October 18, 1987. In return for this use, Vinton will remove the concrete and asphalt at their cost from the property.

The Law Office is reviewing the draft agreement. Gordon McLester moved to approve the request contingent on the review of the agreement by the Law Department. Dave King seconded. Mark Powless opposed. Motion carried.

051-INTRODUCTION OF ROSEMARY HINKFUSS

Rosemary explained that she was running for the State Senate in the 2nd Senate District. She explained what committees and organizations she has been involved with and also pointed out how she felt she could be of service to the people.

150-FINANCE & APPROPRIATIONS RECOMMENDATIONS OF MARCH 18, 1987

Construction Maintenance for B&G - Equipment acquisition for $40' \times 40'$ addition to Maintenance Garage. Estimate includes all but electrical work for \$17,544.00. Electrical is \$1,299.00. Total cost is \$18,843.00. After further discussion, F&A recommends approval, contingent on the identification of funds. Bob Niemela and Jerome Heschler will make an on-site visit to B&G.

Lois Powless moved to approve, Gordon McLester seconded. Motion carried

Center for Television Production Proposal - Request additional financial support for documentary in the amount of 2 - 3,000. This is to be a five minute presentation documenting the Tribe's contribution to Green Bay culture and the traditional role of the wolf in Oneida culture. It will also serve as a permanent record of what the display was, how it came to be presented in Green Bay and what it meant to the Community. F&A recommends disapproval of this project as the Tribe has put forth a substantial contribution (\$20,000) toward the development of the Wolves & Humans exhibit.

Tony Benson moved to approve, Lois Powless seconded. Motion carried.

- (3) Discussion on Tribal Contingency Form Jerome Heschler presented a "Request for Tribal Contingency Funds" form. F&A recommends approval of this form in the effort to provide more information for the accounting office when requesting support from the contingency fund. Mark Powless moved to approve, Tony Benson seconded. Dave King abstained. Lois Powless opposed. Motion carried.
- (4) Equipment Acquisition/Bingo Requests installation of sink and stainless steel counter. Labor at 820.00 and materials at \$3,036.00. Three bids were submitted. B&G for \$3,856.00, Robinson Metal & Roofing for \$4,286.00, Reinhardt for \$4,863.00 and F.W. Boelter Co., for \$5,140.68. F&A recommends approval for B&G for \$3,856.00. No action taken.
- (5) Equipment Acquisition/Bingo Closed Circuit television for promoting better bingo participation through visual display of ball numbers and video recording of prize winners for \$15,969.00 from United Security. F&A requests that this be brought back for additional bids for a lower estimate. No action taken.

(6) Seymour Committee requests \$50.00 for a plaque to be presented to the Superintendent at Seymour School (who is retiring). The Business Committee approved this request but was referred to F&A for identification of funds. F&A recommends approval of the \$50.00 toward the purchase of the plaque. Funds are to come from the JOM Program.

After discussion, Gordon McLester moved that the meeting on April 13, 1987 be a Community Meeting and the previous action for a General Tribal Council meeting be rescinded. Lloyd Powless seconded. 2 yes votes, 3 no votes. Loi Powless and Dave King abstained. Motion failed.

Lloyd Powless moved to have a meeting the the Bingo Staff: Sandra Ninham, Alma Webster, Pat Misikin, Kate Stevens and Attorney Francis Skenandore. Powless seconded. Motion carried.
