- MERFAS The Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States; and,
- WHEREAS The Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin; and,
- WHEREAS The Cheida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council; and,
- HEREAS It is the goal of the Oneida Tribe to protect, maintain and improve the standard of living for its members and the environment in which we live, as well as expanding our tribal land base; and,
- WHEREAS There is a shortage of tribal land available for housing needs
- NOW THEREFORE BE IT RESOLVED that the Tribal Loan Credit Program is hereby established to assist adult enrolled tribal members by providing the initial downpayment toward the purchase of real property for housing to upgrade the present standard of living contingent upon meeting the guidelines and the loan agreement as set forth by the Oneida Tribe; and,
- BE IT FURTHER RESOLVED that the Cneida Business Committee hereby adopt the Tribal Loan Credit Program and that this program be administered by approved procedures through the Cneida Land Office.

- 2) Peter King be approved to apply for a loan through the DePere State with 20% allowance from the Tribe.
- 3) Recommendation to cancel Mr and Mrs. Dale Powless residential lear Poplar Lane.
- 4) Recommendation to accept Peter Kings' residential lease application for above cancelled lease.

After reviewing the recordendations, Mark Powless moved to table until a plan is in place for a Revolving Loan Plan. Gordon McLester Seconded. Tony Benson opposed. Motion Carried.

Rick Hill moved to have Don Wilson, the Land Committee, Chris Doxtator and any Business Committee mamber interested to develop the plan and bring it back within thirty (30) days. Lois Powless seconded. Mark Powless abstained. Motion Carried."

Kathy Hughes moved to take the Land Committee minutes of January 12, 1987 from the table. Dave King Seconded. Motion Carried.

Kathy Hughes moved to refer the request from Peter King to the Land Committee to review the current action and bring back an updated recommendation on this matter. Rick Hill seconded. Dave King abstained. Motion Carried.

The Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States; and,

- WHEREAS The Cheida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin; and.
- WHEREAS The Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council; and,
- WHEREAS It is the responsibility of the Oneida Tribal Business Committee to be responsible for the health, safety and welfare of Oneida tribal members and those people living within the Oneida Indian Reservation; and,
- HEREAS The Oneida Business Committee wishes to protect persons on the Cheida Indian Reservation from the danger of uncontrolled animals that may have been diseased or be dangerous; and,
- WHEREAS It is in the best interest of the Oneida Tribe to keep the Oneida Indian Reservation free from unforeseen dangers.
- NOW THEREFORE BE IT RESOLVED that the Oneida Business Committee hereby adopts the attached Dog Control Ordinance.

ONEIDA TRIBAL DCG CONTROL ORDINANCE AND RESOLUTION #5-5-87-8 (Continued)

After review and discussion Mark Powless moved to approve the Oneida Tribal Dog Control Ordinance and adopt Resolution #5-5-87-B with the omission of Item E, that prevented Fit Bulls being kept on Tribal lands. Rick Hill Seconded. Kathy Hughes opposed. Motion Carried.

Kathy Hughes stated she opposed because of the omission of Item E, dealing with Pit Bulls.

Kathy Hughes moved to amend the Ordinance with the following two changes:

Page 1, Section II. LICENSE

A. All dogs owned by Cheida tribal members and non-tribal members living on tribally caned or leased property must have a tribal license, and must be wearing proof of the tribal license at all times.

Page 3, Section III, DOG BITE CONTROL, Subsection 3., a.

2) Order that the dcg be sacrificed and send the specimen to the State laboratory of Hygiene for analysis (cost borne by the Oneida Health Center). This may be done before the ten (10) day observation period ends.

Rick Hill seconded. Motion Carried.

HOUSING BOARD TERMS

The Business Committee had directed the Tribal Secretary to research the Business Committee minutes regarding the Housing Board terms. In replying to this direction, the Secretary stated that in researching the Business Committee minutes, the records show that Harriet Reiter was appointed on September 14, 1983. Dorothy Powless was appointed on April 16, 1985. Kathy Hughes was re-appointed on April 16, 1985. The terms for the Housing Board are four (4) years and are supposed to have staggered terms. In reviewing the records, we could not find any information how these positions are staggered. At some point, there must have been appointments to fill unfinished terms which is the reason we have two people being appointed on the same date. It is the recommendation of the Tribal Secretary that the Housing Authority or the Business Committee review this record and reconstruct the terms so that they are again staggered and that they have anniversary dates for completion of each term.

Rick Hill moved to approve the recommendation that the Housing Authority reconstruct the terms so that they are again staggered terms and anniversary dates be set for completion of terms. Gordon Seconded. Motion Carried.

FREEDOM OF INFORMATION ACT - FT. HOWARD & B.I.A.

Mr. St Arnold and Mr Barlow

Freedom of Information Act - Appeal - Oneida Tribe

Please be advised that this is an appeal from a decision dated April 7,

The Oneida Tribe contends that

- 1. The information released to Attorney Donald F. Kiesling was not within the scope of Mr. James Morrin's authority based upon the Freedom on Information Act exemption (4) which allows an agency to withhold ". . .trade secrets and commercial or financial information obtained from a person and privileged or confidential". This is analyzed in a Deputy Associate Solicitor's Opinion written by Mr. Timothy Elliott.
- 2. In addition a portion of the information released falls under ". the attorney/client privilege" that acts to create the "Confidentiality" required by exemption (4) (many of the documents released were sent to the Cneida Tribal Attorney).
- 3. That the action taken by Mr. Morrin to release information prior to review by the Oneida Tribe was not just a mistake by "Civil servants who are strong advocates of Indian Tribes" but the action was the breach of a much higher standard, which is the federal trust responsibility that the Bureau of

FREEDOM OF INFORMATION ACT - FT. HOWARD & B.I.A. (Continued)

Indian Affairs is obligated and mandated to maintain. The contention that a breach of trust responsibility occurred is based upon the following facts:

- a. Mr. Morrin spoke with Cneida Tribal Actorney, Francis R. Skenandors on February 27, 1987, and agreed to send to the Cneida Tribe all the subject documents to review prior to their release to Attorney Kiesling; nevertheless, Mr. Morrin released the information to Attorney Kiesling prior to the Oneida Tribes review or objection. Consequently, the Oneida Tribe has been placed in a position of questioning the trustworthiness of its "trustee"; and,
- b. A clear breach of trust responsibility was exhibited by the results of Mr. Morrin's action to release the subject documents while acting in his capacity as a Freedom of Information Officer in that the tribe is now faced with limiting its flow of information to the BIA. Mr. Morrin's action has also placed the tribe in a position of being unable to monitor or control how confidential information which is sent to its trustee is to be used in the future, nor is there any way to determine what substantial harm may have been caused to the trustee, "the Oneida Tribe" by the release of the subject documents.

The above contentions can be summarized as follows:

- 1. The documents released should have been withheld pursuant to exemption (4) of the Freedom of Information Act which allows an agency to withhold "...trade secrets and commercial or financial information obtained from a person are privileged or confidential." USC Section 552 (b) (4). The documents that Mr. Morrin released to Fort Howard through its attorney, Donald Kiesling, included very specific and confidential financial and commercial details of the transactions that led to the development of the Rodeway Inn; and.
- 2. In addition to the financial disclosure issue as stated above. A portion of the documents released to Attorney Kiesling contained environmental testing results that may have been used for litigation purposes. The release of those "Confidential" documents is considered a disclosure of "attorney/client" privileged information which may result in "substantial harm" to the Tribe; and,
- 3. The above explanation and interpretation clearly show that Mr. John Morrin acted outside the scope of his authority as the Freedom of Information Officer for the BIA (as is analyzed in document #2) and in doing so he has breached the federal trust responsibility by not adequately protecting Oneida tribal interests from potential harm.

The attached packet and documents exhibit clearly that the contentions of the Tribe are accurate and the failure of Mr. St. Arnold to discipline Mr. Morrin is an endorsement of his actions to disallow the Oneida Tribe the right

to review and/or object to documents prior to being released pursuant to a Freedom of Information Act Request. Not only is this endorsement contrary to the BIA/Tribal Trust relationship, it is also contrary to federal policy of tribal self-determination.

Sharon Cornelius explained that Mr. Robert St. Arnold has refused to discipline Mr. James Morrin for releasing information to Fort Howard subsequent to the Oneida Tribe's denying such release. In addition, the decision to release the information was clearly against a solicitors opinion to uphold the tribes right to withhold such information.

To allow the above action to take place over objections of the tribe, exhibits a negligence in the BIA's trust responsibility. It also promotes a restriction on the future flow of information between the BIA and the Oneida Tribe. Releasing information without tribal approval may have set a very detrimental precedent to our tribe and all other tribes. Therefore she requested approval to send the letter to appeal the decision of Robert St. Arnold. After discussion, Kathy Hughes moved to approve the request. Rick Hill Seconded. Motion Carried.

The Oneida Tribe, being aware of your intent to leave the NARF organization at the end of September 1987, would like to discuss the potential continued use of your services for the New York Land Claims.

It is our understanding that your intent is to go into private practice upon leaving NARF. If this is so, would you consider entering into a contract with the Oneida Tribe for purposes of on-going legal counsel on the New York Land Claim case? We would be interested in reviewing your proposal to meet our needs.

Gordon McLester moved to approve the above letter. Kathy Hughes seconded. Mark Powless opposed. Motion Carried.

Kathy Hughes moved to adjourn. Gordon McLester Seconded. Motion Carried. Meeting adjourned at 3:30 P.M.
