PROPOSED PLASTIC AMMUNITION BUSINESS - John Powless

John Powless presented the following information:

John's most recent conversation with Mr. Joe Palcher has indicated a need for financing to assist in the marketing of the plastic bullets. Mr. Palcher needs \$60,000 immediately to cover the cost of the following items:

Mr. Palcher also needs \$160,000 to do the tool and die work on the 38, 44, and 45 calibers. A downpayment of \$50,000 to 80,000 would be needed to start the tool and die work, with the remainder needed when the molds are completed.

John presented this information as an update on what is transpiring thus far. He is presently reviewing a joint venture agreement and a recommendation will be forthcoming next week.

John Powless stated that a firing demonstration will be given on Monday, August 17, 1987 here in the area and the Business Committee is invited to attend.

Lois Powless moved to have John Powless set up the demonstration and that the new Business Committee members be invited to attend. Dave King seconded. Gordon McLester abstained. Motion carried.

DRAFT LETTER TO RICK FREEMAN ON GROUNDWATER MEETING

The Oneida Tribe would like to meet with you regarding ground water programs with EPA and to hold a public meeting that evening with Tribal Officials regarding the Indian provisions of the Safe Drinking Water Act. This would probably be held in Oneida and would be scheduled in conjunction with the Menominee and Stockbridge-Munsee Tribes, with other tribes in Wisconsin and Michigan being invited to participate.

We would appreciate having this meeting some time before the comment period expires for the proposed rules.

A location of the meeting and other details will be worked out after a date is set.

DRAFT LETTER TO CHERYL HUENINK RE: PROVIDING SERVICES OF INDIAN CHILDREN AT HOME

It is the purpose of this letter to outline an agreement between the Oneida Tribe of Wisconsin and the Bayfield County Department of Social Services regarding the two-day training program titled "Providing Services to Indian Children At Home."

The training program will be co-sponsored by the Lac du Flambeau Band of Chippewa and the State Department of Health and Social Services, along with the Oneida Tribe of Wisconsin and the Bayfield County Department of Social Services.

Two sessions of the training program are to be held. Session 1 will be held at the Lakewoods Resort, Cable, Wisconsin on August 31 and September 1, 1987. Session 2 will be held at the Oneida Rodeway Inn, Green Bay, Wisconsin on September 3 and 4, 1987.

The total costs for both sessions of the training are projected to be \$11,000.00. Revenue for the training includes \$2,000.00 to be provided to the Oneida Tribe by the Bayfield County Department of Social Services, and \$9,000.00 in grant funding to be provided to the Oneida Tribe by the Lac du Flambeau Band and by the Department of Health and Social Services via the Lac du Flambeau Band.

The attached tentative budget includes all estimated costs for both two-day sessions, and for a total of 120 participants. The tentative budget covers: fees and expense reimbursement for the printing, postage, materials including training manuals, film rental, meeting room rental and administrative costs. The budget also covers the costs of breaks for all participants and the costs of one luncheon meal for each participant.

The Oneida Tribe will be fully responsible for planning, advertisement, registration and on-site coordination. The Oneida Tribe will also be responsible for all disbursement of training funds and will make necessary payments to vendors including the trainer, the training coordinator, the Lakewoods Resort and the Oneida Rodeway Inn.

Upon completion of the training, the Oneida Tribe will provide a final accounting of expenditures, and will bill the Bayfield County Department of Social Services for a portion of the costs not to exceed \$2,000.00. If the actual costs of producing the training prove to be less than the projected costs shown in the attached proposed budget, then Bayfield County will be billed for a share of the actual costs proportionate to the county's share of the projects costs.

MEMORANDUM OF AGREEMENT WITH LAC DU FLAMBEAU

THIS MEMORANDUM of agreement is made and entered into this day of July, 1987, and between the LAC DU FLAMBEAU BAND OF LAKE SUPERIOR CHIPPEWA INDIANS (hereinafter referred to as LDF TRIBE) and the ONEIDA INDIAN TRIBE OF WISCONSIN (hereinafter referred to as ONEIDA TRIBE), pursuant to the following terms and conditions:

- 1. IDF TRIBE hereby agrees to retain the services of the ONEIDA TRIBE for the purpose of planning and coordinating two two-day Indian Child Welfare Training programs, focusing on family-based treatment services for Indian children and families. One program will be conducted on the reservation of the ONEIDA TRIBE and one will be conducted in Bayfield, County, Wisconsin.
- 2. The services to be performed by ONEIDA TRIBE shall be completed on or before September 30, 1987.
- 3. The services of the ONEIDA TRIBE shall be compensated by LDF TRIBE in the total amount of Nine Thousand Dollars (\$9,000). The LDF TRIBE agrees to disburse these funds to the ONEIDA TRIBE in accordance with the proposed budget which is attached hereto. Said sum shall be paid at the times and in the amounts requested by the ONEIDA TRIBE in written form.
- 4. ONEIDA TRIBE shall furnish to LDF TRIBE documentation of expenditures in sufficient detail for the release of funds from the Wisconsin Department of Health and Social Services under Purchase Order FDF 31436; LDF TRIBE shall submit the requisite forms to said Department for the release of funds.
- 5. This agreement shall be effective on the date first noted above
- 6. Modification of the terms of this agreement may be made upon the agreement of both parties hereto, with such modification being attached to this document on a form signed by representatives of both parties.
