## SPECIAL MEETING MEETING WITH ONEIDA TRIBAL SCHOOL BOARD

MONDAY, SEPTEMBER 21, 1987

Meeting called to order at 4:40 p.m.

- A) Amelia Cornelius moved to have Jerry L. Hill write a letter to the Enrollment Office requesting release of information on 16 students on behalf of the Business Committee. Seconded by David King. Motion carried.
- B) Request for \$17,679.44 for 32 weeks to hire another 1st Grade Teacher. Enrollment of 1st grade is 28 students. Space is presently available for the second classroom.

Amelia Cornelius moved to approve the request and to have the hiring of the 1st grade teacher a priority for the Tribal School. Also that funds come from the line item for new employees in the FY'88 Budget. Ernie Stevens seconded.

Amelia Cornelius moved to amend the motion - contingent upon approval of the FY'88 budget. David King seconded. Motion carried.


- C) Need to coordinate efforts of growth of tribal population with new housing and trailer court, with school, Human Services and Health Programs.

Expectation of the school's need to be developed, both long and short range goals. Need to develop Educational Plan.

- D) Budget is to continue on as is until FY'88 Budget is approved by the General Tribal Council in October. The School Board requested more input in the total budget process as it affects the school. David King suggested that all boards, programs and directors be involved in the budget process at the Business Committee level.
