Rick Hill moved to adopt the agenda, Kathy Hughes seconded. Motion carried.

LAND COMMITTEE MINUTES OF NOVEMBER 23, 1987

- Kathy Hughes moved to approve to set aside \$625 from Land funds to cover frost charges for up to five (5) natural gas residents at Green Earth Trailer Court. David King seconded. Motion carried.

- Amelia Cornelius Property: David King moved to refer to the negotiation committee for negotiations. Kathy Hughes seconded. Amelia Cornelius abstained. Motion carried.

b) John Powless requests (emergency) \$200 to travel to N. Carolina for Jr. Olympics. F&A recommends approval with funding from Donations. Rick Hill moved to approve, David King seconded. Motion carried.

The following items were referred to the Community Support Committee. The remaining balance in the Donations fund is \$8,810.30. The budget will be sent to the Committee members listing donations requested thus far.

(5) Dr. Phyliss Cooke, PHD - Human Resource Development: Consultant for \$2,800. Her focus is Human Resource Development which includes levels of training groups in skill improvement and development in areas such as communications, assertiveness, coping skills, etc. F&A recommends approval with funds to come from Business Committee Training budget and General Overhead and also that the eight (8) departments be included in the consultation. WHEREAS, it is the desire of the Oneida Tribe of Indians of Wisconsin that Francis R. Skenandore & Associates, with an office at 3000 Seminary Road, Oneida, Wisconsin, be hired to serve as General Counsel for the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, Attorney Francis R. Skenandore & Associates receive compensation commensurate to the duties performed in accordance with the attached General Counsel Attorney Contract.

NOW, THEREFORE BE IT RESOLVED: that said Attorney Francis R. Skenandore & Associates be employed to act as General Counsel for and on behalf of the Oneida Tribe of Indians of Wisconsin and to appear as such before all federal and state courts, tribunals, departments agencies and committees of Congress and the state legislatures pursuant to the terms and conditions of the General Counsel Attorney Contract attached hereto and incorporated by reference herein.

BE IT FURTHER RESOLVED: that the Tribal Chairman and Secretary of the Oneida Business Committee are hereby authorized and directed to execute the contract employing said attorney as General Counsel in accordance with the attached General Counsel Attorney Contract.
